2016-2017 Miss Shoshone-Bannock Pageant Rules & Guidelines

Contestants, the following rules & guidelines are set forth by the Shoshone-Bannock Royalty Committee (SBRC) to ensure a fair and positive Pageant for all Contestants. These rules apply to all individuals who vie for the title of Miss Shoshone-Bannock, including their parent/guardian and family members (as applicable). Failure by the contestant and/or their family members to abide by Pageant rules may be grounds for the contestant's immediate removal from the Pageant competition.

As a Contestant for the title of Miss Shoshone-Bannock the following criteria & rules apply:

1. Must be an enrolled female member of the Shoshone-Bannock Tribes.
2. Must be between the ages of 18-25 by July 15, 2016
3. We, the committee, highly encourage you as a contestant to reside in Southeastern Idaho or within a 250 mile radius of the reservation if crowned to be able to attend and fulfill the duties required of MSB and attendants during the yearly reign.
4. We, the committee, highly encourage you, if crowned MSB, to compete for the title of Miss Indian World Pageant in April 2017.
5. Must obtain a minimum of three (3) sponsors
6. It is very important for you as a contestant and as an individual to maintain certain moral standards for yourself now and in the future. It is mandatory that you and your fellow contestants to conduct yourselves above and beyond reproach. This means that you will refrain from the use of alcohol, drugs, smoking in public, profane language, and/or outbursts of any kind. Unacceptable socializing with a boyfriend (i.e. intimate displays of affection etc.) in public is not allowed. This type of behavior will not be tolerated. Any infringement of these moral standards will result in being removed from the Pageant as a Miss Shoshone-Bannock contestant.
7. Contestant must have no dependents (children), given birth to any children, nor be expecting (pregnant) dependents. Should you be selected as Miss Shoshone-Bannock, it will **not** be acceptable to cohabit with an intimate companion.
8. Contestant should have a good attitude about themselves before, during and after the Pageant. You will be expected to respect, cooperate, and participate with fellow contestants, the SBRC, judges, Festival committee/staff, the general public, and anyone else you may come in contact with at all times.
9. You are expected and required to attend and be on time to all scheduled events for the Miss Shoshone-Bannock competition (a schedule of activities will be provided to you at Orientation). Failure to do so may result in a deduction of points. It is unfair to contestants who arrive on time and are ready for the Pageant.
10. Attendance for Orientation on July 27th, 2016 is **mandatory**; failure to do so may result in disqualification.

11. Contestants are encouraged to refrain from posting on social media (Facebook, Twitter, etc...) negative status updates, provocative pictures, etc...while participating in the Pageant. If found to have violated this rule, Contestant may be removed from competing in the Pageant.
12. Contestants are also expected to refrain from using their cell phones during the Pageant.
13. All necessary supplies, props, music, regalia, etc...for the various competition events Contestants will be participating in will be the responsibility of the contestant. The SBRC will provide tables, chairs and PA system as needed.
14. The following will be the events you will be judged on (point based), the Orientation will be your opportunity to get further details and what the expectations are:
 - Interview
 - Traditional Talent presentation
 - Impromptu Question(s)
 - Parade
 - Traditional Dish preparation
 - Dance
15. Contestant and her family shall not fraternize with pageant judges before, during, and after the pageant competitions.
16. Contestant & her family members shall show good sportsmanship attitude and behavior toward other MSB Contestants, their family members, pageant judges and the SBRC.
17. Application must be completed and submitted to the SBRC no later than Friday, July 15, 2016 by 5:00 pm.
18. The Contestant(s) that are awarded the Miss Shoshone-Bannock title and/or Attendant(s) will be required to sign a 'Contract Agreement' that will outline the expectations and duties for that upcoming year as a titleholder. Failure or refusal to do so may result in Contestant having the title relinquished from them.
