INDOOR ARENA PEN RENTAL RULES AND REGULATIONS

NOTICE: Trespass Permits will not be required to utilize the Indoor Arena Pens thru August 8th – 15th, 2016 due to the Shoshone-Bannock Indian Festival. Any other days not in this time frame the individual will be required to apply for a Trespass Permit (if they are not a Shoshone-Bannock Tribal Member) with the Land Use Office.

- Any individual abandoning or wilfully neglecting boarded animals shall be fined \$50.00 per day and assessed the full cost of care for the animal, including but not limited to: pen rental, feed, water, veterinarian's services and grooming. In addition, any individual abandoning or wilfully neglecting any boarded animal shall have their Indoor Arena rights immediately suspended and shall only be reinstated pending an investigation into the matter by the Manager of the ARM Program.
- Applicant will be responsible for the upkeep and cleaning of the pen while in use.
- Applicant will maintain a safe environment for all livestock including feed and water.
- Applicant will be liable for any damages to pens during use.
- Applicant will be responsible for people he/she has accompanying them.
- All individuals using the holding pens will be required to have an application on file and have paid their fee with ARM Program before utilizing pens. **NO EXCEPTIONS!**
- Applicants will only utilize the holding pens during their scheduled time. Any unauthorized individual caught using the holding pens will be cited for trespassing and may have their animal impounded and/or fined.
- Anyone caught or using the Indoor Arena after the facility has been closed and secured for the night, will be cited for "Trespassing."
- Anyone found guilty of making a profit off Tribal Property will be cited in the Shoshone Bannock Tribal Court it is unlawful and individuals found in violation will be subject to punishment by Law and / or permanently banned from the Facility.
- **NO ALCOHOL OR DRUGS WILL BE ALLOWED ON THE PREMISES OR IN THE ARENA AT ANY TIME. VIOLATORS WILL BE PROSECUTED AND BANNED FROM FURTHER USE OF THE FACILITY.**

I have read the above rules and regulations for the utilization of the Indoor Arena/Holding Pens and have a complete understanding of each rule and what the Penalties will be if found in Violation.
